#### **ABSTRACT**

#### INTRODUCTION

The term "petrochemicals" refers to feedstocks, the chemicals used in petroleum plants, and the finished products made from feedstocks. Many petrochemical products are valuable, common, and useful items. They include plastics, soaps and detergent, solvents, fertilizers, insecticides, explosives, rocket propellants, synthetic fibers and rubber, paints, drugs, and antifreeze. Petrochemicals are also found in products as diverse as aspirins, luggage, surfboards, polyester clothes, carpets, nylon stockings, and phonograph records (Encyclopedia Americana, 1997).

Ethylene is the most widely used raw material for the petrochemical industry. A by-product of the cracking process, it is used to make ethyl glycol, used as an antifreeze and as the basis for the production of styrene, a major constituent of synthetic rubber, polyethylene, a translucent plastic with countless uses; fabric finishes; latex paints; and many others.
