ABSTRACT

DE VERA, ERICK A., ROGINALD R. ESTERON, CHRISTIAN D. MALIGAYA, AND JAYPEE H. SANCHEZ. *An Analysis of the Community Health Development Projects in Selected Barangays of Naic, Cavite in the Year 2004-2005.* Undergraduate Special Problem. Bachelor of Science in Nursing. Cavite State University, Indang, Cavite. April 2007. Advisers: Dr Josefina Rint and Lenila A. De Vera.

The study was conducted to document the profile of selected barangays in Naic, Cavite. The data gathered by the nursing students were used to assess and evaluate the sustainability of the different nursing projects implemented in selected barangays of Naic, Cavite, and to consolidate the status of all the projects of nursing students of Cavite State University in selected barangays in Naic, Cavite.

The study on health development projects was done in selected barangays of Naic and descriptive type non-experimental research was used. An interview schedule was used in gathering data, through face to face interaction with 160 respondents where 20 respondents were taken from each eight selected barangays. Data were analyzed using frequency and percentage distribution.

Results of the study revealed that among the programs and projects being implemented, cleanliness of the environment had the highest percentage with 38 percent followed by immunization of child with 22 percent and maternal and child care with 17 percent. All projects that were identified and recorded started in 2004. As to the knowledge of the projects, 90 percent among the respondents knew the projects, 91 percent mentioned that the projects were very useful. The most interesting result was 97 percent agreed that nursing students should stay and continue the projects in their barangays.

INTRODUCTION

The municipality of Naic is situated in southern part of Cavite Province. It has a land area of 8,600 hectares and is bounded by the town of Tanza in the north and Ternate and Maragondon in the south. Indang and Trece Martires City in the west and coastal areas in the eastern portion. It is located 47 kms. north of Manila. This municipality is classified as rural, urban or combination, because the western portion is agricultural, the central part is commercialized while the eastern portion is a coastal area. The two main sources of living are farming and fishing although there are commercial spaces and industrial establishments in the poblacion.

It is accessible by land transportation from Manila. Within the municipality, there are tricycles and jeepneys to reach barangays, providing services within the poblacion, thus connecting Naic to the rest of the province. All barangays have electricity.
