ABSTRACT

ADRIANO, CELESTE G. Moldex Realty, Inc. Heritage Homes Trece Martires Field Office. Field Study. Bachelor of Science in Business Management, Major in Marketing, Cavite State University. Indang, Cavite, April 2002. Adviser: Ms.Judith Buena.

An undergraduate field study was conducted in Moldex Realty, Inc. Heritage Homes Trece Martires (MRI-HHTM) Field Office in Trece Martires City. It aimed to describe the operations and activities in the field office and the services given by the personnel to its clients or homeowners, identify the problems and the future plan of the firm, describe the experiences of the author in the conduct of the study, and present recommendations that will help solve the problems identified in the firm.

The operations of MRI-HHTM Field Office is dependent on the other divisions like the Purchasing, Accounting and Accounts. There are seven common activities in the Heritage Homes Trece Martires (HHTM) Field Office. To wit: (1) Housing Inventory Update, (2) Notice to Proceed House Construction Monitoring, (3) List of Corrective Works Monitoring, (4) Repair Request Monitoring, (5) Turned-Over Units Monitoring, (6) Weekly and Monthly Reports Preparation, and (7) Unit Costing and Work Scheduling. The MRI-HHTM Field Office personnel provides its service by assisting in terms of the physical move-in, installation of temporary electric facilities and water line, construction of house extension or fence, provision of shuttle service and clubhouse facilities.

Requesting for supplies, especially for maintenance was the main problem of HHTM Field Office. Numerous complaints of homeowners in different aspects like
