ABSTRACT

The study entitled **EXPOSING THE DEEDS OF DARKNESS: The Level Of Awareness, Knowledge, Attitude And Practice Of Selected Teenagers On Satanic Symbols** was conducted at the Cavite State University Laboratory School during the school year 2001-2002.

This study aimed to find out the number of times the respondents were exposed to the tape and to know the awareness, knowledge, attitude and practice on satanic symbols of selected teenagers. The statistical measures applied were T-test, frequency counts, and percentages.
