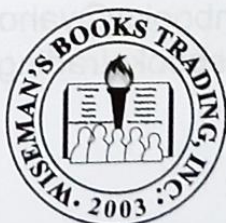

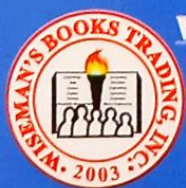
## ABOUT THE AUTHOR
