She was a Colombo Plan Fellow in the University of Sydney for language teaching, a university scholar of the U.P.-BPS Language Teacher Training Program, College of Education, University of the Philippines. She graduated with Bachelor of Secondary Education major in English and History, and Master of Arts degrees from the College of Education U.P. She earned her Ed.D. degree from the Centro Escolar University.

As a teacher-leader she rose from the ranks: from a Department Head (English) to Assistant Principal; Principal I to Principal IV in the biggest high school in the Division of

Rizal which was later converted to a Polytechnic Institute. She passed the Schools Division Superintendent Examination in 1978 and the Supervisor Examination, Civil Service Commission (CSC). As Director IV (BSE) she passed the examination and assessment of the Career Executive Service Board, hence her CES eligibility. She was an Assessor of the Executive Training Program of Educational Management Test (EMT) passers.

She was a faculty on call in Southeast Asia Interdisciplinary Development Institute (SAIDI); and in the School of Education, University of Asia and the Pacific. She was an International Quality Control Monitor of the International Association for the Evaluation of Educational Achievement (IEA) for TIMSS 1999 and 2003. She has gone full circle in the education spectrum – from a high school teacher of English and History; a department head, principal, college superintendent; and on to the DepED Central Office where she supervised the Secondary Education Development Project (SEDP) and the Philippine-Australian Science and Mathematics Education Project (PASMEP).
